O R D E R

1. The application for impleadment is allowed.
2. This is a petition seeking bail.
3. Learned counsel for the respondent/State as well as learned counsel for the complainant have vehemently opposed the petition.
4. Taking into consideration the fact that this Court has already granted bail to the other co-accused, we are inclined to grant bail to the petitioner.
5. The petitioner is directed to be released on bail in connection with FIR No. 487 of 2020 dated 26.10.2020 registered at P.S. Lonavala City, Pune Rural, to the satisfaction of the Trial Court.
6. However, in addition to the condition to be imposed by the said Court, we direct that the petitioner shall not enter the jurisdiction of the Additional Sessions Judge, Vadgaon, Maval, during the pendency of the trial, unless he is required to attend the concerned Court.
7. The special leave petition is disposed of accordingly.
8. Pending applications, if any, stand disposed of.
